
Cricket Pitch on Downley Common.

It is noted that you have taken over the management of West Wycombe Estate for Sir Francis Dashwood.

In your reply of 17th May to my letter of 1st May, there appears to have been some slight misunderstanding. The Council was not in that letter with giving Sir Francis Dashwood permission to fell trees, but that the Council was informed that his forestry manager (Mr Bates) had given permission for five to be felled, but in fact eleven had been felled. Was he aware of this?

Further to this the Council says that it has seen 11 trees felled on the Common, 6 of which were perfectly good living trees, and the Council would like to know to what extent is tree felling to be permitted or continued on the common?

Also, the brushwood from the felled trees has just been left on the Common. The Council would be pleased if you would take steps to secure its removal.



Dear Sir,

Further to my letter of 8th November I am informed that there is no reason why a barrier (open to pedestrians) should not be put along the edge of the road to keep vehicles off the Common, as there is no right at common law to take a car on to the Common. In the absence of a barrier, if people drive on to a Common up to 15 yds from the road, it is only a trespass against the owner of the Common, but if anybody drives a car more than 15 yds off the road on to the Common, he can be prosecuted under Section 18 of the Road Traffic Act 1960.

About three weeks ago, I had occasion to telephone you about your dumping of soil on Downley Common, when you told me that you were acting for Messrs. Mines & West.

I notice that the earth is still in irregular heaps just as it was dumped on the flat. I presume you intend to push this soil into the adjoining dell, and level it off neatly, but I should be glad to know when you propose to do this as I have been asked this question by the Parish Council.

If you have any difficulty, I may say that I am employing a case shovel on the Estate in about 10 days time and it could no doubt carry on to Downley Common and do this work on fairly reasonable terms if you would let me know in good time.
