Re: Downley Common - Horse Riding

I am writing to request most earnestly that you as Agents for the Lord of the Manor take all such measures as are necessary or possible to ensure that the quiet enjoyment of Downley Common by all is not ruined by one section of users.

I am referring to the rapidly increasing and constant use of all parts of the Common by horse riders, in particular for galloping and practising jumping (even to the extent of erecting unsightly jumps on the Common); also by Riding Schools, this presumably being a "business" use.

Several Downley residents have been badly frightened by galloping horses. While I have no wish to spoil the legitimate enjoyment of the Common by any section of the community, I consider that any use which spoils the enjoyment of others should be governed by such strict rules as it is possible to enforce.

I would suggest for your consideration:-

- (1) That notices should be erected making it clear that horse riders must restrict their use of the common to defined bridleways.
- (2) That any horse grazing on the Common should be securely tethered, the tether to be restricted to a reasonable length.
- (3) That horse owners using the Common for grazing should be asked to produce evidence of their grazing rights.
- (4) That where the Common has been badly rutted, for instance by its use for practising jumping, the horse owners should be called upon properly to reinstate the turf.

In view of the rapidly increasing use of the Common by horse riders, I feel that urgent steps are necessary; otherwise Downley Common is going to become a recognised area for horse riders (resident in Downley and elsewhere).

This beautiful Common for generations past has been revered by Downley residents, and the peace of the Common has been enjoyed by residents and others. Please do everything possible to preserve the continuance of this amenity for the enjoyment of all.

Horseriding on Commons

There is no actual right to ride a horse on a common except on a bridlepath. At the same time it is not a criminal offence and the only illegality is vis-a-vis the Lord of the Manor or owner of the soil i.e. it is a trespass.

Where a common is subject to a right of public access e.g. owned by the National Trust, access granted by Deed or Scheme, byelaws can be made making various restrictions on access. In such a case it would probably be necessary to set aside some area for riding.

Where a common is managed under a Scheme under the Commons Act 1899 byelaws can be made.

We are, however, very concerned that the trees recently provided by Sir Francis and planted by yourselves on Downley have been vandalised, possibly by a "Commons Preservation Group". We should be glad to have your views on this incident and to know what action you are taking to repair the damage.


We have received complaints from our members that trees, which have recently been put up by the Village Hall, High Street, Downley, have been vandalised, the damage being extensive.



F. Letter by West Wycombe Rural Parish Council of 21st Sept. 1972.

The term 'REPEAT' the objections that the COUNCIL wish to object etc. appeared to be a contradiction of our assertions.

To avoid delay, a Trustee searched the Council's Minutes, and could not find any record of resolutions to offer opposition, either at the Planning Application stage or to your Ministry.

The following are true copies of all the minutes bearing on the subject:

11 Feb. 1971. Turn round area at Sunnybank Chapel, proposed Chair & agreed that Mr. Nobbs' views be obtained on this matter.

23 March '71 Turnround near Sunnybank Chapel, proposed by Chair & agreed that Trustees of Chapel be asked for their views on the turnround made up of 11 inches of concrete/ tarmac.

29th. April '71 Sunnybank Turnround Downley Common, proposed Clr. Butler that council decide in principle whether it wants a turn round to be provided. Against a turn round, Messrs Plumridge, Butler, Free, Wolfe, Page, Langley. Abstained: Clr Hardy. (2 did not vote)

13th July. Turnround for vehicles Sunnybank Chapel, proposed Clr. Langley and agreed that Trustees be informed that the majority of this Council decided to do nothing at the present. (5 for. 1 against 3 abstained)

The following relate to this application:

29th. February 1972. Letter from Moor Lane Chapel was submitted requesting the approval of the Parish Council to the provision of a turn-round for hearses & it was agreed that no objection should be made to this proposal.

(28th March) Annotation: Mrs Langley objected to the proposal.

28th. March '72. It was proposed by Mrs. Langley & agreed that the Council write to the Trustees of the Moor Lane Chapel & inform them that, if they
